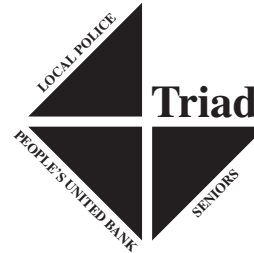

- Merge onto CT-9 S via EXIT 39A toward NEWINGTON/NEW BRITAIN
- Take the ELLA GRASSO BLVD exit, EXIT 29, toward CT-75/NEWINGTON
- Turn RIGHT onto ELLA GRASSO RD
ELLA GRASSO ROAD becomes
ELLA GRASSO BOULEVARD
- Turn LEFT onto CT-71/STANLEY ST
- 1615 STANLEY STREET

FROM HARTFORD POINTS SOUTH

- I-91 North toward HARTFORD
